## **MLS signs on to the Library Copyright Reform Statement on eBooks.**

Over the past three years, Congress, the Department of Commerce, and the Copyright Office have all begun investigating the need to “reform” the current Copyright Act in the face of rapidly evolving technology. Most recently, the Library of Congress has initiated a Notice of Inquiry seeking public input regarding whether and how Section 108, the “library and archives exceptions,” should be amended to accommodate modern technology.

This Statement presents considerations the signatories of the Statement (libraries, library associations, publishers, and other entities) believe are imperative to maintaining the constitutional purpose of copyright law in the face of contemplating statutory changes to address modern technology, specifically the move from ownership of copyright-protected works to licensing.

The MLS Executive Board approved signing on to this important statement to encourage consideration of library access to eBooks as copyright provisions are under discussion at the federal level. For more information, please visit:
